

## Contents Distribution Service Terms and Conditions

### Article 1 (Application of Terms and Conditions)

1. These Contents Distribution Service Terms and Conditions (these “Terms and Conditions”) are the Basic Service Terms and Conditions applicable to the Basic Service, “Contents Distribution Service” (the “Service”) which SAKURA internet Inc. (the “Company”) provides.
2. The user of the Service (the “User”) shall observe the Basic Terms and Conditions which the Company sets forth. The Basic Terms and Conditions together with these Terms and Conditions shall apply to the Service.

### Article 2 (Definitions of Terms)

1. “Contents Distribution Service” shall mean the service to cache static contents on multiple servers and distribute such contents.
2. “One- time URL” shall mean the URL effective only for a certain period which the User designates starting from the time when the URL is generated and issued.

### Article 3 (Contents of Service)

1. The Service is the service to provide the following functions.
  - (1) File Storage  
A function to store distribution contents in a storage disc space. The User accesses the storage server by FTP or SSH connection and uploads distribution contents data.
  - (2) Contents Distribution  
A function to distribute contents data for distribution which the User uploads to storage servers from cache servers for data distribution. The contents distribution maintains a stable speed in processing distribution on the side of a server by receiving requests from an access source at the load balancer, dispatching them to a group of cache servers for data distribution in which multiple servers are connected in parallel and distributing loads of each cache server for data distribution. In addition, this method makes data distribution servers redundantized so that it improves the availability of the data distribution system itself.
  - (3) FTP Transfer  
An FTP transfer function to upload contents to storage servers. The User accesses storage servers by using an issued account and password and uploads contents data for distribution.
  - (4) SSH Transfer  
A function to upload contents to storage servers via SSH. The User accesses storage servers by using an issued account and authentication method and uploads contents data for

distribution.

(5) Control Panel

A function of a web page for management by which the User may check a usage graph, resource value, amount of usage by month and cache management.

(6) One-time URL Authentication

With respect to a one-time URL, a function to verify whether the relevant one-time URL is one duly issued or not.

Article 4 (Use Start Date)

1. Notwithstanding the provisions of the contract period in the Basic Terms and Conditions, provision of the Service shall start from the use start date of which the Company notifies the User irrespective of confirmation of the first payment of the fees.

Article 5 (Payment of Fees)

1. Notwithstanding the provisions of the payment deadline in the Basic Terms and Conditions, the User shall pay the fee for the use of the Service for the period from the 1<sup>st</sup> day to the last day of each month by the last day of the following month.

Article 6 (Minimum Use Period)

1. Notwithstanding the provisions of the minimum use period in the Basic Terms and Conditions, there shall be no minimum use period for the Service.

Article 7 (Termination of Use Contract)

1. Notwithstanding the provisions of termination in the Basic Terms and Conditions, the User may, by giving the Company a notice in a manner prescribed by the Company, terminate the Use Contract effective as of the day on which the User gave the notice.

Supplementary Provisions

Article 1 (Commencement of Application)

These Terms and Conditions are the amended version of the Contents Distribution Service Terms and Conditions which applied on and after January 28, 2016, and shall apply on and after May 8, 2020 pursuant to the provisions on the amendment to the terms and conditions in the Basic Terms and Conditions.
