

Secure CMS Service Terms and Conditions

Article 1 (Application of Terms and Conditions)

1. These Secure CMS Service Terms and Conditions (the “Terms and Conditions”) are the Basic Service Terms and Conditions applicable to the Basic Service, “Secure CMS” (the “Service”) which SAKURA internet Inc. (the “Company”) provides.
2. The user of the Service (the “User”) shall observe the Basic Terms and Conditions and these Terms and Conditions which the Company sets forth. The Basic Terms and Conditions together with these Terms and Conditions shall apply to the Service.

Article 2 (Contents of Service)

1. The Service is the content management system equipped with domain authentication, WAF (Web Application Firewall) and security measures for tamper detection as standard.

Article 3 (Subcontracting)

1. The Company may subcontract all or part of the Service to antant co., ltd. (the “Designated Business Operator”).

Article 4 (Upper-Level Terms of Use)

1. The User shall comply with the latest “Secure CMS Service Terms of Use” (the “Upper-Level Terms of Use) which the Designated Business Operator sets forth at the time the User uses the Service.

Article 5 (Application)

1. The User may apply for the Service only if the User has an address, a residence or a business office in Japan.

Article 6 (Use Start Date)

1. The use Start Date of the Service shall be determined depending on the day on which the Company confirms that the payment of the initial usage fees has been completed. With respect to the payment of the initial usage fees, if the Company confirms it within a period from the 1st day to the 20th day of every month, the use start date shall be the 1st day of the following month, and if the Company confirms it within a period from the 21st day to the last day of every month, the use start date shall be the 1st day of the two (2) months following month.

Article 7 (Minimum Use Period)

1. Notwithstanding the provisions of the minimum use period in the Basic Terms and Conditions, the minimum use period of the Service shall be one (1) month from the use start date.

Article 8 (Termination)

1. Notwithstanding the provisions of the termination date in the Basic Terms and Conditions, the User may, by notifying the Company within a period from the 1st day to the 20th day of every month, terminate the Use Contract for the Service effective as of the last day of the present month, or, by notifying the Company within a period from the 21st day to the last day of every month, effective as of the last day of the following month.

Article 9 (Use by Third Party)

1. The User may not transfer, sell or allow the use of the Service to a third party without obtaining the Company's permission.

Article 10 (Support)

1. The User shall contact the Designated Business Operator for supports concerning the method of use, functions of the Service and the Upper-Level Terms of Use. The Company shall not support these.
2. Except the supports set forth in the preceding paragraph, the Company shall respond to inquiries concerning the Service.

Supplementary Provisions

Article 1 (Commencement of Application)

1. These Terms and Conditions are established on July 15, 2021 and shall apply on and after the same date.
